Old Business: Trustee Nelligan has a guest speaker to talk about paving the Pickleball Courts at Perry Park, Brian Fowler. The Pickleball club would like to have a hybrid Pickleball court along with the Tennis court and the Pickleball club would take on the responsibility of the expenses. They would take care of the painting on the court. It could still be used as a tennis court. Pictures of the tennis courts and what would be done were provided. Trustee DeChiara asked whether holding the Pickleball tournaments in Perry Township would provide revenue for the Township and Brian was unsure what if any monies this would bring in. Trustee DeChiara asked how they would divide the court up for someone who wants to play tennis versus pickleball. Brian responded stating the hybrid court would only be utilized when the other courts were also being used. Brian stated while the tennis courts in his opinion were not being utilized very often it would then become an expense for the Township to transform the courts to just Pickleball courts. ### **Public Speaks:**

### **Bruce Mencer**

Bruce stated his address as 538 Roxbury Ave N.W. Massillon. Bruce had a question on the culvert on 12<sup>th</sup> Street and Summerdale and wondering how much of the cost was being covered by Perry Township. Trustee Miller stated he did not have that information at this point. Trustees stated they would get that information to him this week from Administrator Martin.

### **Linda Cameron**

Linda Cameron stated her address as 443 Canford Ave. N.W. Linda thanked the Township for the pens and that the Spirited Senior group would put them to good use at future meetings. Linda stated that the Spirited Seniors would be willing to volunteer to assist the Parade and Oktoberfest coming up.

Linda asked who was responsible for cleaning up after the use of a pavilion if the person who reserved the pavilion did not clean up after themselves such as broken glass, or charcoal. Trustee Miller stated that they do have employees who monitor the parks from time to time but no one to follow up after a reservation was had at a pavilion.

Linda stated that many people walk dogs, children in strollers, bike riders, etc. and she has spoken with the Zoning Inspector in previous years regarding the lot on the corner of Canford and Bailey across the street from the Fire Dept. much of the weeds are now 6-foot shrubs along with poison sumac with berries and poison ivy. It is clear out where the pavement starts and the branches from the trees scrap the tops of the trucks and school buses as they go by. Children could get scratched as bike riders. Linda stated that whoever owns the property needs care for these things. Trustee DeChiara said they could take care of the trimming and the weeds back from the street.
