Carol Stone & Michael Stone

Carol stated her address as 3221 Rayanna N.W. Massillon 44646. Carol stated she had a complaint on 3227 Rayanna, they have 7 husky dogs, 4 children, and 2 adults living in a 900 square foot home. Carol stated the neighbor will not mow the grass, or clean up after the dogs, they throw trash all over the ground. She had the idea that if a person does not do what they need to do once a complaint is made, they should be fined. Zoning Director Jeff explained to the Board the situation with the neighbors. Trustee DeChiara suggested to the Zoning inspector setting up guidelines for repeat offenders. The zoning Inspector said he would visit the residents to assist in addressing concerns.

Stacey stated her address was 5129 14th St S.W. Canton 44710. Stacey stated she and her husband live behind Fire Station number 1 and the lot adjoins the extra lot 5115. She has concerns someone else will acquire that property and she would like to purchase it and wanted to address the Board on how to purchase the property. She previously inquired about purchasing and came up with nothing, and now she would like to follow up and find out the process of purchasing it. Trustee DeChiara stated it is hard to decide on the property without knowing the future of the Fire Dept and what the space could be used for and if it were to be sold, they would not have rights to the property. Trustee Miller said a conversation with Chief Sedlock can be done and keep them in consideration if they do decide to sell the land.

Lisa Barnes & Jessica Riff

Jessica stated they were served with a stop work order from the Zoning Inspector the other day and they are parked on her mother's property on her taxes it states the property is a commercial property. To her knowledge, she thought it was okay since they were parked on commercial land, and once a neighbor complained she found out the property was considered residential. Jessica stated they clean up after themselves, do not play loud music, and close before it is dark. Jessica does not understand that her parents pay each year to classify the property as commercial land. Trustee DeChiara said while he likes the idea of the business, they must treat every situation the same, what they do for one they have to do for everyone else. Law Director Matthews suggested to the ladies to get a variance in the meantime to be able to use the property until changes need to be made for them to be able to park at her mother's property. Trustee Miller said the Board will see what they can do to help and get back with the ladies.
