i) Consider the purchase of new equipment. The Public Works Director would like to purchase a CAT 920 Loader with attachments for \$206.912.37 along with a CAT 305 Excavator with attachments for \$98.846.25. The purchase will include a trade which will take off \$88,500.00. Trustee DeChiara brought up his dislike for making this purchase out of the road budget since the income is in a dire state, he suggested putting the funds in a capital reserve account and making the purchase a year from now. DeChiara stated we have 1 more year with the yard waste to use this equipment for. PWD Wellman stated with the equipment they are having transmission issues and will cost more to fix than to purchase new. Trustee Miller made a motion to approve the purchase of the two pieces of equipment not to exceed 217,258.62 to be paid out of account number 2031-330-599-0000. Seconded by Trustee Nelligan.
